Call to Order

Reports and Presentations

- Director's Report
 - *Presented by Richard Campbell*
 - Visitation
 - CHM site-wide visitation for the month of July and year-to-date totaled nine thousand, two hundred and twenty-one.
 - School Groups
 - For the month of July and year-to-date, school group/summer programs visitation totaled eight hundred and twenty-five.
 - Membership

- Membership has increased by one hundred and twenty-three memberships with a total revenue of \$9,705. The CHM overall memberships are at one thousand, four hundred and three.
- Past Events
 - Living History Saturday: "Recreation and Leisure: 18th Century"
 - Each Saturday during the month of August, Historic Brattonsville hosted a series of living history events, focusing on recreational and leisure activities from the 18th and 19th centuries. These activities included games, crafts, dancing, and sports.
 - World Snake Day
 - On July 20th, the Museum of York County hosted World Snake Day. This event focused on the fascinating qualities of snakes as well as learning how to support their conservation. One hundred and twenty-two visitors were in attendance and were greeted by Josie Brown and her pet snake Toto.
 - Fish with Teeth Camp
 - From July 23rd- 26th, the Museum of York County hosted Fish with Teeth Camp for children ages six to twelve. Sixty-seven participants enjoyed various interactive games and crafts, while learning about fish with teeth.
 - Wake Up Sleepyhead
 - The Main Street Children's Museum hosted Wake Up Sleepyhead on July 27th to celebrate National Sleepyhead Day. Seventy-two visitors participated in reading a bedtime story, counting sheep, and learning a lullaby.
 - Lovely Lions
 - For World Lion Day on August 10th, the Main Street Children's Museum presented Lovely Lions, where our youngest visitors had the opportunity to use their imaginations and enjoy various lion-themed activities and crafts. One hundred and one visitors participated in this event.
 - World Lion Day
 - The Museum of York County also participated in World Lion Day by hosting a drop-in program, where visitors explored the American lion that once roamed the Carolina Piedmont during the Ice Age. Visitors also learned about present-day lions. Seventy visitors came out for this event.
 - Camp Piedmont & Institute of Museum and Library Services Grant
 - On August 8th, the Museum of York County received the news that the would be receiving a grant from Institute of Museum and Library Services, to develop Camp Piedmont: An Early Learner Playscape. This

new space will open in the fall of 2027 and will align with MYCO's mission.

- Upcoming Events

- Nothing Finer than South Carolina

- The Main Street Children's Museum will be hosting a celebration for National South Carolina Day on August 31st. Our young visitors will have the opportunity to participate in various interactive activities to celebrate the state of South Carolina.

- Nature at Your Door

- On September 7th, the Museum of York County will be hosting Dr. Sara A. Gagne, author and University of North Carolina Charlotte professor, on September 7th for a discussion on ecosystems and the natural world.

- By the Sweat of Our Brows

- This annual event will be taking place on September 14th at Historic Brattonsville. Visitors will have the opportunity to interact with both black and white Bratton descendants and learn about their shared history. Beginning at 10:30am, the traditional "Calling of the Names" will kickoff this event. Various activities as well as guided tours and demonstrations will take place throughout the day.

- George Sheppard asked about author that attended the event either last year or the year before. Richard Campbell said that he will get the information to George Sheppard about the author and her book.

- Evening with Meredith Connelly

- On September 18th, the Museum of York County will be hosting artist Meredith Connelly, who is behind our summer exhibit "Decomposers Glow". Attendees will learn about how she creates her illuminated displays and will have the opportunity to create their own nature-inspired print collages.

- Worldwide Day of Play

- On September 28th, the Main Street Children's Museum is partnering with Nickelodeon and the Association of Children's Museums for this year's Worldwide Day of Play celebration. ACM will be supporting play initiatives with a \$500 stipend and special guest, SpongeBob SquarePants, at no additional charge.

- CHM Project Updates

- Fluid Preservation Room

- The walk-in freezer for the Fluid Preservation Room has been successfully installed. However, issues were found with the electrical breaker that will require a design modification and a formal proposal to repair. In addition, the general contractor submitted three proposals to

alter the designed canopy, which were all rejected as they did not meet the specifications outlined in the project work plan. The contractor indicated that the originally designed canopy could be provided, it would delay the completion of the project. We have communicated that the original design is our preference. The contractor will proceed with the project as we wait on the canopy.

- Ice Age Hall
 - The Ice Age Hall mural was installed on July 29th. During this install, Exhibits noticed that the Jefferson Ground Sloth's tail was broken. In response, a new foam tail was fabricated to replace the previous heavier plaster tail. The Ice Age Hall reopened to the public on August 7th.
- Lowery Family Theatre
 - Midwest Maintenance Inc. is currently in the process of obtaining a building permit from the City of York while their fire sprinkler subcontractor has prepared updated drawings of the sprinkler systems for the auditorium. These drawings will be reviewed by the Office of the State Fire Marshal. The City of York has requested a code analysis by a South Carolina-licensed design professional to address additional issues. Bennett Preservation Engineering contends that these requirements may not be necessary under the International Existing Building Code and is working to clarify this with City officials. Further outcomes depend on the outcome of Bennett Preservation Engineering's discussions with the City of York.
 - Eddie Lee suggested to Carey Tilley to go to Brian Rose, the Deputy Fire Chief, to discuss the fire codes. Richard Campbell clarified that Carey Tilley did consult with Brian Rose and he will circle back with on the communication.
 - George Sheppard ask about what the State Fire Marshal's office said about the project. Richard Campbell replied that we have not heard back from them yet.
- Col. Bratton Cabin Exterior Preservation Project
 - Midwest Maintenance Inc. has completed their scope of work on the Homestead House, final approval from the architect was received on August 14th. Structural repairs to the decayed log wall are ongoing and the proposal for additional design work has been approved. CHM preservation is currently working with Matteo Ferran Structural Engineers, PLLC to arrange a site visit. Plaster repairs requiring a contractor are currently on hold until the structural work is completed.
- Homestead House Exterior Preservation Project

- Midwest Maintenance Inc. has completed their scope of work on the Homestead House, final approval from the architect was received on August 14th. Following Tropical Storm Debby, leaks were identified at the chimney and windows, leading to the discovery that the step flashing had been incorrectly installed by the roofing subcontractor. This has been since corrected by Midwest Maintenance. CHM Preservation will be installing copper-alloy weather stripping to the window sashes to resolve the issue.
- Watt Cemetery
 - Four hundred and eighty-eight graves have been confirmed by ground penetrating radar, with the final report due by October 31st. The Exhibits Department has been fabrication sixty-eight additional grave markers and projects to begin installation by August 28th. Following the completion of fencing installation on June 28th, the parking area was finished on July 18th. We are currently working with York County IT to bring the security system up to speed.
 - Exhibits has scheduled installation of the markers and demoed last week.
 - The descendants met last night about panels and coming up with a name for the cemetery and an opening date. We will be receiving feedback in the next few weeks about a name. There is talk of opening in November but Richard Campbell would like to propose opening the cemetery in February, allowing us to have all of the IT concerns resolved and it would tie into our annual By Way of the Back Door event.
- Shake Roof Replacements: Work Barn, Original Outbuilding, & Original Smoke House (HB)
 - Benton Roofing Incorporated has been engaged for the shake roof installation. The manufacturer has delayed the production, Benton Roofing expects the receipt of the shakes to be delivered by late August or early September. Installation will follow the delivery of the shakes.
- Hightower Hall Wedding Program
 - A photoshoot took place at Hightower Hall on July 2nd to promote the building's marketing materials. Mark Cockerille arranged for a wedding party, including a horse drawn carriage, for this event. The party and guests consisted of volunteers, four local models, and a few of our commissioners. A promotional video was also filmed.

Past Events

Living History Saturday: "Recreation and Leisure: 18th Century" (HB)

Every Saturday in August, staff, historic interpreters, and costumed volunteers conducted a series of living history events, highlighting recreational and leisure activities from the 18th and 19th centuries. The program began on August 3 with a focus on 18th-century pastimes, including nine-pins, children's games, and English country dancing. On August 10, the events centered on the leisure activities of enslaved people, featuring demonstrations of marble-making and corn husk doll creation. August 17 showcased 19th-century pastimes with displays of fancy needlework, card games, and period dancing. The series concluded on August 24 with a sports-themed day, featuring archery, horseshoes, and baseball.

World Snake Day (MYCO)

World Snake Day was celebrated at MYCO on July 20. Visitors explored the fascinating qualities of snakes and learned how to support their conservation. Interpreter Josie Brown and her pet snake, Toto, were present for a special meet-and-greet. The event attracted 122 participants.

Fish with Teeth Camp (MYCO)

Fish with Teeth Camp ran from July 23 to July 26, offering children aged 6 to 12, a week of marine life exploration. The camp featured various interactive games, activities, and crafts designed to both educate and entertain. We hosted 67 enthusiastic participants, ensuring a memorable and enjoyable experience for all in attendance.

Wake Up Sleepyhead (MSCM)

Wake Up Sleepyhead took place at the Main Street Children's Museum on July 27 to mark National Sleepyhead Day. Visitors enjoyed reading a bedtime story, counting sheep, and learning a lullaby. The event welcomed 72 participants.

Lovely Lions (MSCM)

Lovely Lions took place on August 10 to celebrate National Lion Day. Our youngest visitors used their imaginations to practice roaring, stalked imaginary prey throughout the museum, and created lion-themed crafts. The event featured a Vernon Grant tie-in with a take-home lion craft from the Bild-a-Zoo set. We had 101 participants.

World Lion Day (MYCO)

World Lion Day was held on August 10 as a drop-in program, where visitors explored the American lion that once roamed the Carolina Piedmont during the Ice Age and learned about contemporary African lions. The event attracted 70 participants. Attendees appreciated the opportunity to view the lioness, along with exhibits and collections that were specially brought out of storage for the program.

Camp Piedmont & Institute of Museum and Library Services Grant (MYCO)

On August 8, the Institute of Museum and Library Services announced the 2024 grant awards for the Museums for America program. The Museum of York County received a grant of \$64,470 to develop Camp Piedmont: An Early Learner Playscape. This three-year project, slated to open in the fall of 2027, will replace Tot Town and offer a new early learning space better aligned with MYCO's mission.

Upcoming Events

Nothing Finer than South Carolina (MSCM)

On August 31, the Main Street Children's Museum will host a celebration for National South Carolina Day, offering our young visitors interactive activities such as playing with local animal puppets, embarking on a pretend voyage to Charleston, and creating classroom flags.

Nature at Your Door (MYCO)

On September 7, Dr. Sara A. Gagne, author of [Nature at Your Door](#) and Associate Professor of Landscape Ecology at the University of North Carolina Charlotte, will lead a discussion on the natural world. Participants will explore our connection to ecosystems, our impact on environmental cycles, and ways to positively influence local and broader landscapes.

By the Sweat of Our Brows (HB)

Each September, Historic Brattonsville hosts “By the Sweat of Our Brows,” an event dedicated to honoring the legacy of the enslaved community through the active participation of their descendants. Since 2005, this event has provided an authentic narrative, allowing visitors to meet both black and white Bratton descendants and learn about their shared history.

This year’s event, titled “A Living Legacy,” begins at 10:30am on September 14, with the traditional ‘Calling of the Names’ from Harriet Bratton’s 1865 Freedmen’s List. The day features demonstrations by period-dressed interpreters, of African American foodways and trades, including blacksmithing and hand-sewing, with a focus on the clothing of enslaved people. Attendees can explore the Reconstruction Era at the Brick House’s recreated Brattonsville Store and view the award-winning exhibit Liberty & Resistance. The event includes panel presentations by Bratton descendants at 11am and 2pm, family-friendly activities such as make-and-take toys and old-fashioned games, and the operation of the historic cotton gin each hour from 11am to 3pm. Guided site tours are available at noon and 3pm, and a presentation on the preservation of spaces occupied by enslaved people is scheduled for 1pm. New hydration stations will be provided for our visitors, and concessions will be available for purchase.

Evening with Meredith Connelly (MYCO)

On September 18, attendees will spend an evening with Meredith Connelly, the award-winning multidisciplinary artist behind our summer exhibit "Decomposers Glow." They will learn how she creates her remarkable illuminated displays and will have the opportunity to make a print collage with natural elements to take home.

Worldwide Day of Play (MSCM)

The Main Street Children’s Museum is partnering with Nickelodeon and the Association of Children’s Museums (ACM) to celebrate play. This year’s event takes place on September 28, and will include activities such as hula-hooping, basketball, and dancing, promoting a day of fun and physical activity for Worldwide Day of Play. ACM is supporting these initiatives with funding, and MSCM has received a \$500 stipend for its participation. Additionally, ACM is also sending SpongeBob SquarePants at no additional cost.

CHM Project Updates

Fluid Preservation Room (MYCO)

The walk-in freezer has been successfully installed. However, the electrical sub-contractor encountered issues finding the correct breaker for the designated panel and has proposed using a different, closer panel instead. This change will require a formal proposal since it constitutes a design modification. Additionally, the general contractor submitted three proposals to alter the designed canopy, all of which were rejected as they did not meet the specifications outlined in the project work plan. Although the contractor indicated that they could provide the originally designed canopy, this would delay the project’s completion. We have communicated that the designed canopy is our preferred option. Consequently, the contractor will proceed with the rest of the project while we wait for the canopy.

Ice Age Hall (MYCO)

The Ice Age Mural was installed on July 29. Upon unwrapping, it was discovered that Jeffrey the Jefferson Ground Sloth's tail was broken. In response, the Exhibits team fabricated a new foam tail to replace the original heavy plaster one and used a more durable attachment rod for installation. The Ice Age Hall officially opened to the public on August 7.

Lowery Family Theatre (McC)

Midwest Maintenance, Inc. is in the process of obtaining a building permit from the City of York. Pye-Barker, their fire sprinkler subcontractor, has prepared updated sprinkler system drawings for the auditorium, which will be reviewed by the Office of the State Fire Marshal. The City of York has requested a code analysis by a South Carolina-licensed design professional to address additional issues, including occupancy classification and fire-rating. Bennett Preservation Engineering (BPE) of Charleston, SC, contends that these requirements may not be necessary under the International Existing Building Code and is working to clarify this with City officials. Additionally, architectural drawings for a fire-rated wall to separate the auditorium from the McCelvey Center may be required, depending on the outcome of BPE's discussions with the City.

Col. Bratton Cabin Exterior Preservation Project (HB)

Midwest Maintenance, Inc. (MMI) has completed their portion of the project, receiving final approval from Joseph K. Opperman Architect (JKOA) on August 14. Structural repairs to the decayed log wall are ongoing. The proposal for additional design work by Matteo Ferran Structural Engineers, PLLC (MFSE) has been approved, and CHM Preservation is working with MFSE to arrange a site visit. Plaster repairs requiring a contractor are on hold until the structural work is completed.

Homestead House Exterior Preservation Project (HB)

Midwest Maintenance, Inc. (MMI) completed their scope of work, receiving final approval from project architect Joseph K. Opperman (JKOA) on August 14. Following Tropical Storm Debby on August 8, CHM Preservation identified leaks at the chimneys and windows of the Homestead House. Water tests by MMI and Assistant Site Director Joe Mester revealed that the step flashing at the chimneys had been improperly installed by the roofing subcontractor; MMI has since corrected this. The window leaks were due to wind-driven rain and not related to MMI's work. CHM Preservation will install copper-alloy weather-stripping on the window sashes to resolve the issue.

Watt Cemetery (HB)

Ground Penetrating Radar (GPR) has confirmed 488 graves, with the final report due by October 31. The cemetery's security system faces challenges due to its remote location, lack of Wi-Fi, and unreliable cell signal. A plan is being developed with the York County IT Chief Information Officer to enhance signal coverage and bandwidth, with the County funding many of the improvements. Additional costs for camera upgrades, equipment, and monthly fees will be incurred. The County is currently preparing expense projections and a project timeline. Fencing installation, including an extra 184 feet of aluminum, was completed on June 28. The Exhibits Department has begun fabricating 68 additional

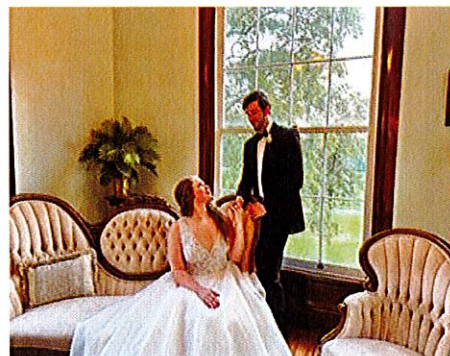
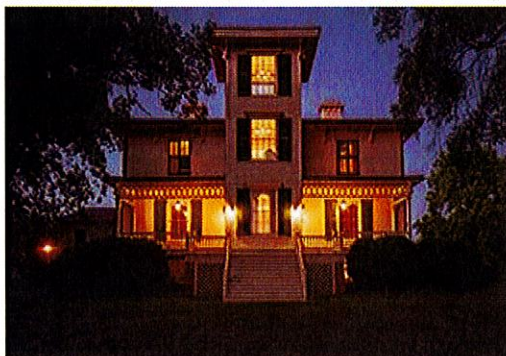
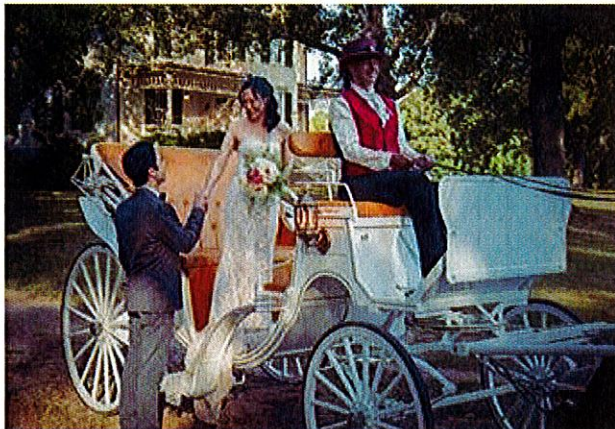
grave markers, with a trial installation tentatively scheduled for August 28. The parking area was finished on July 18.

Shake Roof Replacements: Work Barn, Original Outbuilding, & Original Smoke House (HB)

CHM has engaged Benton Roofing, Incorporated of East Flat Rock, NC, for roof installations. The production of the shakes has been delayed due to the manufacturer's need for splitting and pressure treating them. Benton Roofing expects to receive the shakes by late August or early September, with installation scheduled to begin soon after delivery.

Hightower Hall Wedding Program

On July 2, a photo shoot was held at Hightower Hall in collaboration with a local wedding planner, who organized a bride, baker, photographer, and florist for the event. CHM Rental and Events Manager Mark Cockerille also arranged for a bride and groom, guests, a photographer, flowers, and a horse-drawn carriage. The photos from this shoot will be used to refresh Hightower Hall's wedding marketing materials. Additionally, the CHM Marketing Department filmed a promotional video at Hightower Hall, featuring over twenty extras, including four models from a local agency and several commissioners (Annie Laurie, Ed Stewart, and Ms. Margaret).

Significance/Ownership History Mission Rating: 5,3 (Scale of 1 – 5; 5 matches mission 100%)
 The donor’s late husband, Stewart Graham (1939-2023), was an avid collector of Vernon Grant memorabilia purchasing most of his collection online. Stewart was originally born in Nashville, Michigan, just 23 miles north of Battle Creek, Michigan, home of Kellogg’s Headquarters. He graduated from Kellogg High School in 1957. He also served in Michigan’s National Guard and Air Force Reserves before opening his own printing shop and became publisher of a weekly newspaper called *The Olivet Optic*. He sold the business in 1977 and relocated to Ada, Ohio where he lived until his death in July 2023.
 Due to his VG collecting, Graham personally met Vernon and Lib Grant, getting added to their annual Christmas card list receiving the iconic VG Santa Claus card directly from the Grant family. He also became acquaintances with former VG Curator Mary Lynn Norton and loaned a couple of his personal VG items to the Museum of York County for exhibition in the early 2000s.
 Vernon Grant was an American illustrator and commercial artist throughout most of the 20th century. Famous for creating Snap! Crackle! and Pop! gnomes for Kellogg’s Rice Krispies cereal, his artwork was seen on a number of magazine covers, advertisements, food packaging, and children’s toy packaging. After moving to Rock Hill in 1947, Grant became Director of the Rock Hill Chamber of Commerce and then Director of the Housing Authority of Rock Hill. He also redirected some of his focus from art to focus on farming and soil/land conservation. Grant’s artwork serves as inspiration for two Rock Hill annual events, ChristmasVille and Come-See-Me, as well as CHM’s Main Street Children’s Museum.

George Tillman Johnson Jr (1929-2020) is the son of Martha Ford Johnson (1905-1985) and George Tillman Johnson (1897-1964). He graduated from York High School in 1945 (when it was grades 1-11) and attended Spartanburg Junior College where he met his wife Sara Moss Johnson (1930-2024). They raised four daughters. He worked at Brandon Furniture Company in York until the store closed then he was employed at Gaston Memorial Hospital in the security division. He retired at age 73. He is buried in Rose Hill Cemetery in York.

Katie Lou Johnson Culp (1927-2005) is the eldest child of Martha Ford Johnson (1905-1985) and George Tillman Johnson (1897-1964). She graduated from York High School in 1944 then Winthrop College in 1948 and earned her master of education from the University of South Carolina. She taught math for many years in the Fort Mill School District and retired after 37 years. She married David G. Culp Jr (1917-1996). They are both buried in Unity Cemetery in Fort Mill.

The **White Rose Annual** is the yearbook for York High School. The Yorkville Female College was founded in 1852 on the grounds of 212 E Jefferson Street (McCelvey Center) and continued until it became the Yorkville Graded School in 1889. The original building burned on November 16, 1900 due to a chimney fire with a new building being erected in 1902. The central portion and east wing of the building were added in 1922. It became the York Elementary School in 1951 when grades 9 - 12 moved to the newly built high school (now Harold C. Johnson Middle). The building underwent renovations in 1956 when the annex was built. In 1973, the school was renamed McCelvey Elementary

School in honor of Mr. George C. McCelvey, who was principal from 1912 – 1948. The last day of school held in the building was June 4, 1987.

Class of 1945 Reunion booklet contains an event agenda as well as a short paragraph for each classmate providing an update on their lives including education, occupation, hobbies, as well as contact information and family members.

Our History in Review contains photos and histories of Clover and York including local businesses, schools, early settlers, Catawba, and churches to commemorate the millennium.

Charles Albert Cannon (November 29, 1892 – April 2, 1971) was the son of Cannon Mills Company founder James William Cannon and president of the firm from 1921-1962. He was born, lived and died in Concord, North Carolina. See: https://en.wikipedia.org/wiki/Charles_Albert_Cannon

The **Cannon Mills Company** was an American textile manufacturing company based in Kannapolis, North Carolina, that mainly produced towels and bed sheets. Founded in 1887 by James William Cannon, by 1914 the company was the largest towel and sheets manufacturer in the world.^[1] Cannon remained family-owned until 1982 when it was sold to David H. Murdock. Murdock sold the company to Fieldcrest in 1985, becoming Fieldcrest-Cannon. The company was sold to Pillowtex Corporation in 1997, which entered bankruptcy in July 2003. 


 The donor had the ring and bracelet passed down from his mother's side of the family, originally belonging to his 2x great-grandmother, **Permela Harriet Thomas Davis (1833-1877)**. Family oral history suggests that the bracelet was found by Isaac Newton Davis in Virginia on his way back to SC from the Civil War. He found it in a tin can along the road.

Permela married **Isaac Newton Davis (1831-1908)** in 1857 and had three children, all of whom were born in South Carolina. Both Permela and Isaac are buried in Oakwood Cemetery in Gastonia, NC. Their first son, **William Jefferson Davis (1861-1898)** was married twice, having five children with his second wife was **Mary Valeria Beaty (1860-1931)**. William and Mary's youngest surviving child was **Ada Enola Davis (1896-1965)**. She married **Cleveland Preston Shirley (1884-1969)** and had 2 children, one of which was the donor's mother, **Nell Shirley Stewart (1925-2013)**.

The chicken cookie jar was sold at Crest 5c, 10c & 25c Stores in York, SC as suggested by the price tag on the bottom. Crest was located at 23 N. Congress St. The earliest record of Crest was in 1939 in The Herald but it was also listed in the York City Directory from 1958 until 1968. The cookie jar belonged to **Francis "Frankie" Elizabeth Quinn (1922-2013)**, a distant relative to the donor, who also lived in Clover, SC. Francis was born to **Haskel Young Quinn (1899-1981)** and **Lola Jane Earle (1898-1959)** in York County, SC. She married **William Leslie Wray (1924-2000)** and worked as a spinner at a local textile mill. She is buried at Lakeview Memory Gardens in Clover.

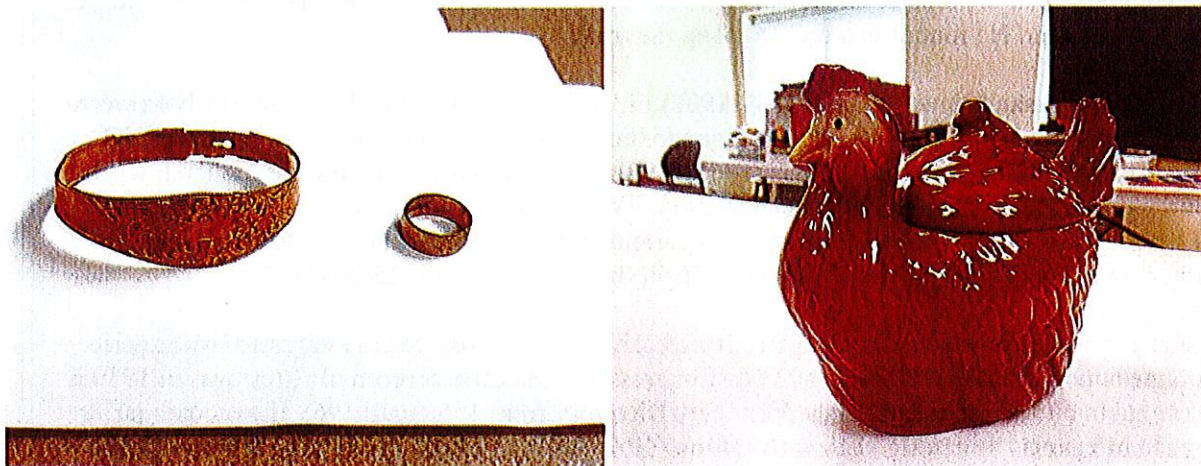

The Eagle Scout troop 38/238 was sponsored by Oakdale Presbyterian Church in Clover, SC. Four of the boys, Brett Brackett, Scott Brannock, Ben Drechsler, and Andrew Love became Eagle scouts in 2002. The other boys seemed to be involved in the Eagle Scouts in early to mid-2000s. Given the more recent time period these are from, research sources are limited in providing any other information on the individual names.

Eagle Scout is the highest rank attainable in the Boy Scouts of America. Since the inception in 1911, only 4 percent of boy scouts have earned this rank. The rank has been earned by over 2.5 million youth. In order to earn the rank, scouts have to have earned at least 21 merit badges, managed and participated in an extensive service project, and demonstrated the Scout Spirit.

The donor Fran Bertelli bought the cookbook from an unknown seller in NC on eBay and the advertising meat fork from another unknown seller on eBay, location unknown. She collected cookbooks from her mother's collection and donated one to the archives in February of 2023 along with several other archival documents. Fran said she had been looking for a copy of this particular cookbook for many years and when she finally found one she felt it deserved to be back in York. She is a retired school librarian and she served on the library board of directors in Chester County, Connecticut in the 1970s. The donor attended many family reunions in South Carolina over the years and visited Hickory Grove to see family. She likes to collect interesting items from York County because of her maternal ancestors which is why she purchased the advertising meat fork on eBay.

The donor's mother **Alice Howell** (1916-2007) was born and raised in Hickory Grove, SC and moved to Connecticut when she married Louis Nathan Bertelli (1914-1986), a craftsman carpenter. They are buried in Saint Josephs Cemetery in Chester, Connecticut. Alice Howell Bertelli (1916-2007) is the daughter of William Isom Howell (1872-1940), a farmer, and Sarah Jane Edwards Howell (1878-1928). Both are buried in Sharon Associate Reformed Presbyterian Churchyard in Sharon.

Cookbooks generally contain recipes for soups, salads, side dishes, main dishes, desserts and beverages as well as cooking tips, measurements and substitutions. They also provide insight into meal preparation, popular ingredients, and offer a bit of family history with recipes being submitted by church or community members.

Divine Savior Church located at 232 Herndon Ave in York, SC was founded in 1938. The Sisters of Charity of Our Lady of Mercy from Charleston began Divine Savior Hospital in 1938 in a house donated by the Church Carroll family on South Congress Street. Mrs. Carroll was the first Catholic in York and welcomed the opportunity to attend mass in York without having to go to Chester or Rock Hill. Soon the J.C. Falls family and B.A. Lewis family joined the sisters in their chapel for Sunday Mass. As the number of Catholics grew a priest was assigned from the Oratory in Rock Hill to the Divine Savior Mission. In 1963 the Mission was raised to the parish status it now enjoys. In April 1964 ground breaking was held for the construction of a church on Herndon Avenue designed by architect Frederick H. Schmitt of Charlotte. The new church cost approximately \$90,000 and members held their first service on December 24, 1964 for Christmas Eve Midnight Mass. In 1988, Divine Savior Parish celebrated their 25th Jubilee (1963-1988).

Yorkville Enquirer

In 1889, the *Yorkville Enquirer* was one of the oldest weekly newspapers in the state having achieved 35 years of continuous publication with 31 of those years under the same proprietor, Lewis M. Grist. Equipped with the Campbell two-revolution press, they were able to print 1600 newspapers per hour and mailed copies to subscribers both locally and in other southern states.

A fire on November 23, 1890 destroyed the Yorkville Enquirer building, Mr. J.W. Dobson's residence, and damaged two houses across the street. The fire originated in the cellar of the Enquirer building on North Congress Street and entailed a loss of \$10,000 including the building, type, presses, engine, and subscription books. The following day, printer's supply men came to Yorkville and Grist ordered a new press. He and his son then headed to Philadelphia to purchase the remainder of the necessary equipment. Six weeks after the fire, Grist published his first issue on January 7, 1891 from a temporary location in the Kennedy Bros. & Barron building. A year later, the Enquirer office moved into their new brick building at the site of their old office on North Congress Street.

About Yorkville Enquirer (Yorkville, SC) 1855-2006

For over 150 years, the *Yorkville Enquirer* served the communities of Hickory Grove, McConnells, Sharon, Smyrna, and Yorkville (present-day York), located in York County, South Carolina. Through much of its existence, the *Enquirer* was edited and published by the Grist family, so much so that the family and the newspaper were nearly synonymous in the minds of Yorkville residents. John E. Grist, the family patriarch, had previously worked for the *Pendleton Messenger* before relocating to Yorkville. In the 1840s, he started a number of short-lived newspapers, including the *Yorkville Journal of the Times*, *Yorkville Compiler*, and *Farmers' Miscellany*. In 1851, John Grist (1807-1870) sold the *Farmers' Miscellany* to his son, Lewis Mason Grist (1831-1903), who renamed it the *Yorkville Miscellany*.

On January 4, 1855, Lewis Grist launched an entirely new paper, the *Yorkville Enquirer*, "an independent journal for the promotion of the political, social, agricultural, and commercial interests of the South." John L. Miller and Samuel Wickliffe Melton served as editors and proprietors. The accolades came quickly flowing. On May 9, 1855, the editor of the *Edgefield Advertiser* wrote, "The pains you bestow upon your admirable sheet, brother editors, should not only command commendation, but should draw into your fold a host of paying subscribers."

At the outbreak of the Civil War, Lewis Grist turned over the management of the *Enquirer* to his father John Grist and enlisted in the Confederate States Army. During the war, the *Enquirer* only suspended publication twice, in spite of paper shortages. In the years following the war's end, York County became ground zero in an undeclared war of racial terror on African Americans. In 1871, the members of the local chapter of the Ku Klux Klan were deemed responsible for having committed at least ten murders and approximately 600 assaults on Black residents, provoking President Ulysses S. Grant to place Yorkville under martial law. Lewis Grist appears to have distrusted the Klan and the Union Leagues (formed to bolster support for the Republican Party) in equal measure. On April 13, 1871, he approvingly quoted a recommendation from the *Charleston Daily Republican* that, "Let us have done with these secret organizations... Let us now openly grapple with our difficulties, and the very fact that our efforts are open, will cause many of those difficulties to vanish."

In the 1890s, Lewis Grist turned over control of the *Yorkville Enquirer* to his sons Lewis George, Wood Davidson, Oliver Ellis, Albert Mason and Reginald M. Grist. Under Wood Davidson Grist's leadership, the *Enquirer* successfully transitioned from a weekly to a semiweekly paper and increased its circulation. In 1943, the Grist family sold the *Enquirer*, having conducted it as a family business through several generations. In 2006, the *Yorkville Enquirer* was merged with the *Clover Herald* and became the *Enquirer-Herald*. The last issue of the *Yorkville Enquirer* appeared on March 16, 2006.

This item was created by the donor’s mother. The donor’s mother Mary “Andy” R. Lowry had donated family memorabilia in 2000, 2008, and 2012 which was added to RG-21 Lowry Family Papers. The donor also donated her parent’s marriage license in 2020. This item contributes to the information on the family members.

RG-21 Lowry Family Papers

The Lowry Collection primarily contains family histories, correspondence, property records, reunion records, and newspaper clippings relating to the activities of the Lowry family. The collection also includes photographs, publications, AV materials, Barnett and Bennett Bros. Circus papers, and some documents relating to the history of York, York County, South Carolina. The family papers document the Lowry – Avery Clan but also include information about the Arthur, Avery, Bettrill, Bratton, Brice, Carroll, DeLoache, Dunovant, Gardner, Gaston, Hay, McClure, Miller, Moore, Starr, Twitty, Vaughan, Walker, Wilson, and Witherspoon families.

Susan Lowry Mason is the daughter of Mary Anne “Andy” Robinson Lowry (1927-2012) and Samuel Kenneth “Bo” Lowry, Jr. (1925-2020). Her parents were married by E. Gettys Nunn, probate judge on September 7, 1949. They had a church wedding September 15, 1949 in the Episcopal Church of the Good Shepherd at York.

Mary Anne “Andy” Robinson Lowry (1927-2012) is the daughter of Rev. Clayton Earle Bullis Robinson (1890-1979) and Susan Jeannette Chase Robinson (1889-1976). Andy graduated from Margaret Hall Episcopal High School in Versailles, KY and Woman’s College of the University of NC in Greensboro. She was a member of the Tau Psi Omega sorority and Cornelian Society. Andy served as president of the Episcopal Churchwomen of Upper South Carolina in the late 1970s. She married Samuel Kenneth “Bo” Lowry, Jr. (1925-2020) on September 7, 1949. They had two sons and two daughters.

Samuel Kenneth "Bo" Lowry, Jr. (1925-2020) is the son of Samuel Kenneth "Bo" Lowry, Sr (1891-1978) and Mary Starr Lowry (1890-1979). He attended York High School and Darlington Academy in Rome, GA. He served as a Pharmacist Mate in the Navy during WWII from 1943 to 1946. He then earned a pharmacy degree from the Medical University of SC in 1950. He owned and operated the York Drug Store for 37 years; he was instrumental in developing Kennedy's Mixture with his father. He was a founding member of the York Jaycees and served on the York District School Board and with P.A.T.H. of York County.

Preserving personal and family memorabilia in a book form has been around since the 15th century. Typical memorabilia include printed media, artwork, and photographs. With the increase in printed materials during the 19th century, the hobby of scrapbooking became more popular. The modern industry of scrapbooking began in 1980 and doubled in size by 2003. Due to social media and digital photography, traditional scrapbooking has transitioned into new layouts and a variety of sizes

Adding this family scrapbook to the Lowry Family Papers provides information for family historians and genealogists. In addition, this item could be useful for researchers interested in history of photography, scrapbooking, fashion, and Christmas traditions.

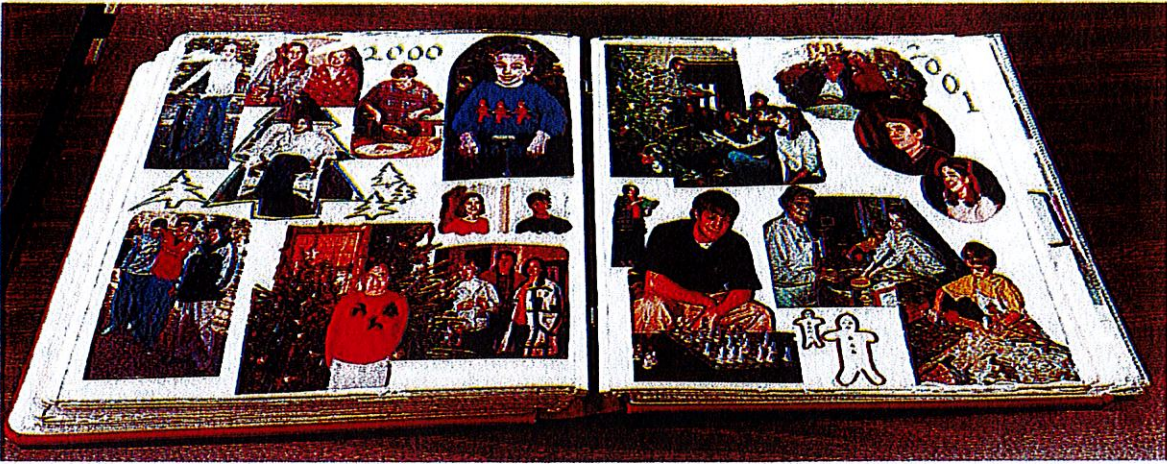

Request for funds from MWYC Expense Account (5000-45045-000)

Requested By: Jillian Bingham, Director of Collections and Nancy Sambets, Director of Archives

Request Date: August 8, 2024

Following the dissolution of the Museum of Western York County (MWYC), their board voted to close any/all accounts and donate any remaining funds to CHM. On March 3rd, MWYC treasurer Gay Feemster officially made the donation of \$49,125.31 with the restriction that the funds go towards the care of MWYC items that were transferred to CHM. In December 2022, CHM finalized the transfer of more than 1400 items and over 140 boxes of archival material to both the permanent and education collections. The entirety of the donated funds have been placed in a restricted equity account (5000-45045-000) in accordance with York County purchasing procedures.

The Collections Department requests to use \$10,218.15 to hire a part-time intern for a total of 600 hours to process the MWYC Object collection. The hired intern would work solely on the MWYC Collection to ensure ethical use of the restricted funds. They would finish cataloging and housing the MWYC collection, ensuring it gets preserved properly and added to the collections management database. Once in the database, the entire collection can be made visible to the public through the online database (<https://chmuseums.pastperfectonline.com/>). If all cataloging is complete before working 600 hours, the hired intern would research the collection, further documenting the provenance and relevance to CHM's mission. The hiring of a part-time intern to work with the MWYC collection allows the Collections Department to process other donations, inventory the collection, and preserve the rest of the permanent collection, while also preparing for AAM Reaccreditation.

The Collections Department also requests the use of \$500 to relocate the MWYC square grand piano (ED2022.003.001) from Hightower Hall (HTH) to McCelvey Collections Storage. There is a strong desire to have a functioning piano at HTH for rentals, but the MWYC piano is unable to be tuned due to its age and style. Its relocation to McCelvey would provide the necessary space for a functioning piano to be put in its place. All other costs associated with the replacement of the HTH piano will be the responsibility of a different CHM department.

The Archives Department is requesting to use \$9,665.25 to purchase a new shelving unit for the Historical Center's archives compact shelving system. The current units lack enough space to house at least 73 boxes of MWYC archival material. The Archives Department also requests to use \$371 to purchase oversized archival folders for proper storage of MWYC oversized items.

Below is a summarized cost breakdown of MWYC Expense Account with the applicable quotes attached. The requested funds include a \$500 contingency to account for changes in shipping that have been documented to occur between budgeting and purchasing.

The hired intern would work an estimated 24 hours per week for 25 weeks (600 hours total). They would work solely on processing the Museum of Western York County (MWYC) Collection. If they were to finish processing the 1400+ items that were received in the 2022 transfer, the paid intern would then focus on further research of the collection, documenting provenance and relation to CHM's mission of preserving the natural and cultural histories of the Carolina Piedmont.

York County hourly rate for paid interns: \$15.82/hour

FICO Tax rate: 7.65%

24 hours x \$15.82 = \$379.68/week

\$379.68 x 25 weeks = \$9492.00

\$9492 x 0.0765 = \$726.15

\$9492 + 726.15 = \$10,218.15

Total requested funds for paid MWYC intern: \$10,218.15

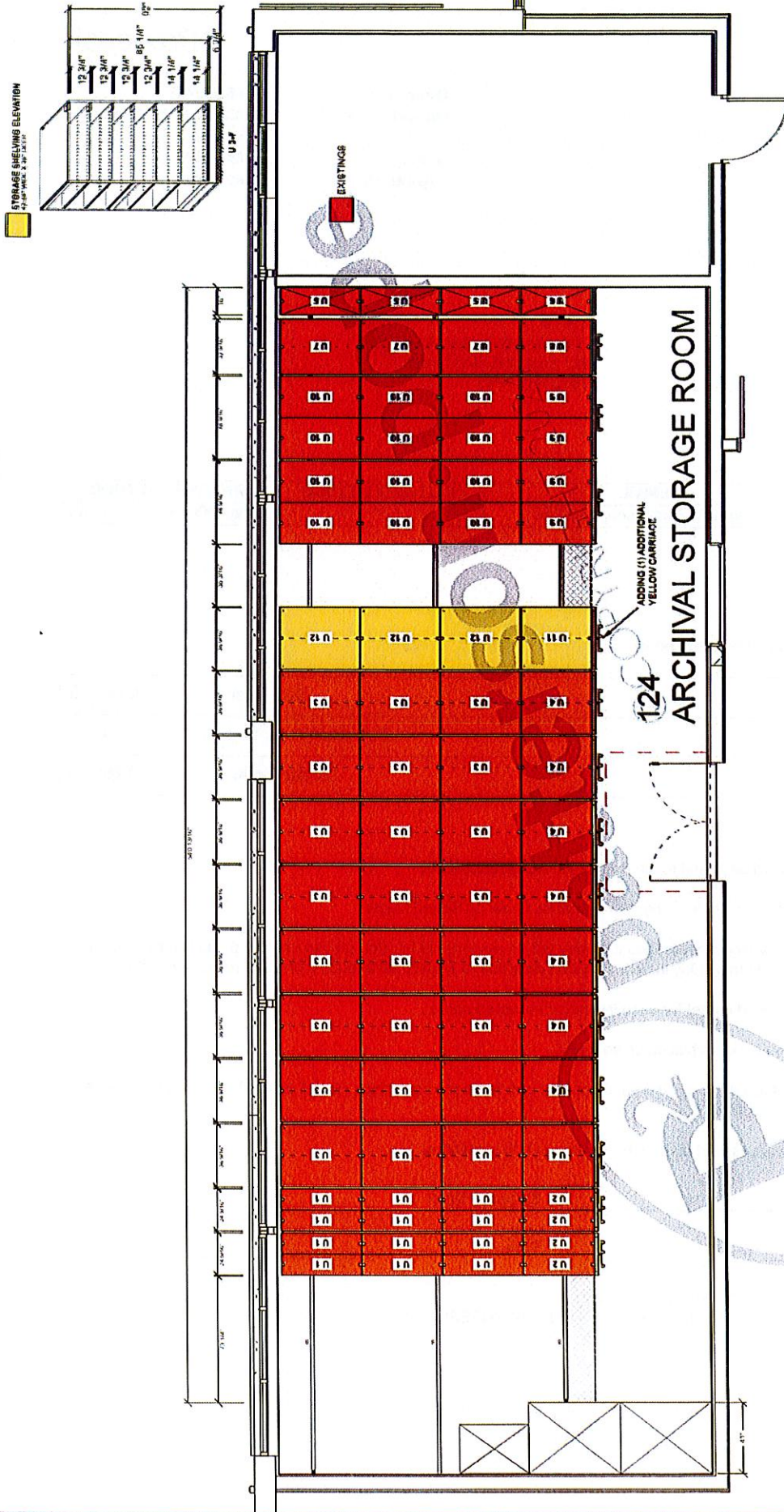

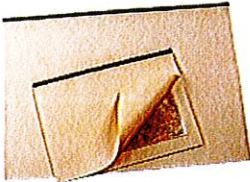
